Pay for Chairs of Committees

Today we have announced our Final Report and Determination on pay for Chairs of Select Committees and for Members of the Panel of Chairs. This followed a consultation which was published in March. Both are available on [our website](#).

The salary for Chairs of Select Committees will remain at its current level of £15,025 a year. For Members of the Panel of Chairs, we have streamlined the pay structure, under which Panel Members receive a salary according to their length of service, and have implemented a single salary rate. This will be set at £15,025 a year, the same level as for Chairs of Select Committees. These changes will be reflected in salaries in June 2016.

We have also agreed to index pay for Chairs to the rate of annual change in average earnings in the public sector, as with MPs' basic pay, for adjustments in future years. The first of these adjustments will be made in April 2017.
